The Commission has received information that LIBRA 5/777 PRIVATE FOUNDATION OF THE PHILIPPINES 2001, INC. is being used by SLOBEC REALTY DEVELOPMENT CORPORATION to collect money in the form of "membership fees" from its recruited "members". In return, "members" are promised large amounts of money as incentive.

Our records show that the Certificate of Registration of SLOBEC REALTY DEVELOPMENT CORPORATION was REVOKED on July 2, 2002 for failure to comply with the reportorial requirements.

The public is therefore advised to take the necessary precautions before entering into transactions with the above-named entities.
