The Securities and Exchange Commission (SEC), through the General Appropriations Act (GAA) intends to apply the sum of **Eight Hundred Forty Nine Thousand Five Hundred Pesos (Php 849,500.00)** being the Approved Budget for the Contract (ABC) in payment for the **Supply, Delivery and Installation of Various IT Equipment** listed hereunder. Bids received in excess of the ABC shall be automatically rejected during bid opening.

SEC now invites bids for the **Supply, Delivery and Installation of the abovementioned Various IT Equipment**. Delivery of the Goods is required for a period of thirty (30) calendar days from the issuance of Notice to Proceed and/or Purchase Order. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.


Interested bidders may obtain further information from the BAC-IT Secretariat, and inspect and purchase the Bidding Documents at the MIS Division, 7<sup>th</sup> Floor, SEC Building, EDSA Greenhills, Mandaluyong City starting **26 February 2010** upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos (Php 1,000.00).

SEC will hold a **Pre-Bid Conference on 05 March 2010, 10:00 A.M.** at the ERID Conference Room, 7<sup>th</sup> Floor SEC Building, EDSA Greenhills, Mandaluyong City, which shall be open only to all interested parties who have purchased the Bidding Documents.

The **deadline for submission of bids will be on 17 March 2010 at 10:00 A.M.** at the BAC-IT Secretariat, MIS Division, 7<sup>th</sup> Floor, SEC Building and **immediately thereafter, opening of bids will be held at the 7<sup>th</sup> Floor Conference Room, SEC Building, EDSA Greenhills, Mandaluyong City.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.

The SEC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
