In spite of notice and demand, the company has failed to submit the required reports and pay the assessed penalties.

Pursuant to the resolution of the Commission in its meeting on 04 December 2008, the company's Registration of Securities and Certificate of Permit to Sell Securities to the Public are hereby **SUSPENDED** for a period of 60 days from the date of receipt of this Order or until the company submits the required reports and pays the penalty in full<sup>2</sup>, whichever comes first.

Should the company fail to comply with the above directive within the said period, the Commission shall immediately initiate proceedings for the revocation of its Registration of Securities and Certificate of Permit to Sell Securities to the Public.

Let a copy of this Order be posted in the Commission's official website for the information and guidance of the public.
