Submission of duly signed Price Quotation Form (Attachment 1) and eligibility documents is not later than 10:00 A.M. of October 18, 2019 at the Procurement Division, 3rd Floor, Secretariat Building, PICC Complex, Pasay City. The penalty for late deliveries is one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual delivery or performance. Once the amount of liquidated damages reaches ten percent (10%), the Procuring Entity may rescind or terminate the Contract without prejudice to other courses of action and remedies open to it.

The SEC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
