TERMS AND CONDITIONS:

- 1. Bidders shall provide correct and accurate information required in this form.
- 2. Price quotation/s must be valid for a period of thirty (30) calendar days from the date of submission.
- 3. Price quotation/s which shall be in Philippine peso shall include all taxes, duties and/ or levies payable.
- 4. Quotation/s exceeding the Approved Budget for the Contract shall be rejected.
- 5. Award of contract shall be made to the Single/Lowest Calculated and Responsive Quotation (for goods and infrastructure) or, the Highest Rated Quotation (for consulting services).
- 6. Any interlineations, erasures or overwriting shall be valid only of they are signed or initialed by you or any of your duly authorized representative/s.
- 7. The item/s shall be delivered according to the accepted technical proposal and specified in the Notice of Award.
- 8. Brand of the offer, if required, should be indicated as part of the bid. Non-indication of the brand may be considered as ground for disqualification. Sample, if required, shall also be submitted as part of the quotation. Non-submission of sample may be considered as ground for disqualification.
- 9. The SEC shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- 10. In case two or more bidders are determined to have submitted the Lowest Calculated and Responsive Quotation, the rules on Tie-Breaking as provided under the existing rules shall be observed to arrive at the LCRQ.
- 11. Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with the existing accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be to the contractor's account.
- 12. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed for day of delay. The SEC shall rescind the contract once the commutative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

TECHNICAL SPECIFICATIONS

Project: Printing of The SEC Reports 2020-2023 (Q1)

I. BACKGROUND

The SEC Reports 2020-2023 (Q1) is a publication of the Securities and Exchange Commission (SEC) which demonstrates its unwavering commitment to pursuing programs and reforms from 2020 to 2023 (Q1). It also highlights the Commission's initiatives in support of the President's eight-point socioeconomic agenda, as well as efforts to mitigate the impacts of the COVID-19 pandemic through digital transformation.

II. SCOPE OF WORK

The printing company shall print 50 copies of The SEC Reports 2020-2023 (Q1) in close coordination with the SEC Economic Research and Training Department – Strategic Management and Planning Division (ERTD-SMPD), including but not limited to the following tasks:

- 1. Revise the layout, if necessary, in consultation with SEC ERTD-SMPD;
- 2. Submit Press Proof and obtain a final sign-off from SEC ERTD-SMPD before submitting electronic files for printing/mass production; and
- 3. Submit a digital copy of The SEC Reports 2020-2023 (Q1) to the SEC ERTD-SMPD to be stored in a USB device and should be in print-ready format compatible with commercial printing.
- 4. Deliver the printed and digital copies of The SEC Reports 2020-2023 (Q1) within 15 working days upon approval of the sample print in a packaging using recyclable materials, to prevent damage or deterioration during transit of the same.

III. ELIGIBILITY REQUIREMENTS

- 1. Must be registered with the Philippine Government Electronic Procurement Systems (PhilGEPS);
- 2. Must be a reputable company with printing capabilities and/or printing company that can operate and provide off-set printing services with at least 5 years in the business;
- 3. Must have experience in lay-outing and printing of a government agency report for at least 3 years; and
- 4. Must be able to provide 3 to 5 samples of quality brochures/manuals/annual reports (hardbound) produced/printed within the last three (3) years (for presentation purposes only).

IV. APPROVED BUDGET OF THE CONTRACT

The approved budget of the contract is Three-Hundred and Thirty-Four Thousand Pesos (Php 334,000.00), or Six Thousand Six Hundred Eighty Pesos (Php 6,680.00) per copy, to be charged against the FY 2023 SEC Approved Operating Budget under RA 11232.
