In the event that the national or local government declares suspension of work by reason of fortuitous event or an event beyond the control of the SEC, the deadline to submit quotation is automatically moved to the next working day, same time and place of submission.

Quotations exceeding the Approved Budget for the Contract shall be disqualified.

The bidder with the single or lowest calculated and responsive quotation, or the awardee, shall be required as condition for the issuance of Notice of Award the submission of the following, unless the requirements were already submitted as part of the quotation or were previously submitted as part of another bid:

- 1. Valid Mayor's/Business Permit;
- 2. PhilGEPS Registration Number; and
- 3. Income/Business Tax Return [for projects with ABC above Php 500,000.00];.

The following are the terms and conditions of this RFQ:

- 1. Sub-contracting is not allowed.
- 2. Bidders who have been determined to have unsatisfactory performance in any government contract may be disqualified from award.
- 3. Prices quoted shall be valid for a period of thirty (30) calendar days from the date of the opening of bids.
- 4. Price quotations shall be in Philippine peso and shall include all applicable taxes and/or levies.
- 5. Award of contract shall be made to the Single/Lowest Calculated and Responsive Quotation (for goods and infrastructure) or the Highest Rated and Responsive Quotation (for consulting services).
- 6. In case two or more bidders are determined to have submitted the Lowest Calculated and Responsive Quotations or Highest Rated and Responsive Quotations, the rules on Tie-Breaking as provided under the existing rules shall be observed to arrive at the S/LCRQ or HRRQ.
- 7. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 8. The goods or services item/s shall be delivered according to the accepted technical proposal specified in the Notice of Award.
- 9. Brand of the offer, if required, should be indicated as part of the bid. Non-indication of the brand may be considered as ground for disqualification. Sample, if required, shall also be submitted as part of the quotation. Non-submission of sample may be considered as ground for disqualification.
- 10. SEC shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

- 11. Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with the existing accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be to the contractor's account.
- 12. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed for day of delay. The SEC shall rescind the contract once the commutative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
- 13. The SEC reserves the right to reject any and all quotations, declare a failure of bidding, or not award the contract without thereby incurring any liability to the affected bidder or bidders.

# PLACEMENT OF RADIO ADVERTISEMENTS FOR INVESTOR EDUCATION AND OTHER INFORMATION CAMPAIGNS

### **BACKGROUND**

The Securities and Exchange Commission (SEC) is a national government regulatory agency mandated to register and oversee corporations in the Philippines. At present, it supervises more than 600,000 active corporations. It also enables and regulates the capital market, a crucial component of the Philippine financial system and economy, toward good corporate governance, protection of investors, widest participation of ownership and democratization of wealth.

The SEC must progressively perform its critical role as the prudent registrar and supervisor of the corporate sector and the independent guardian of the capital market, with the growing number of corporations and other forms of associations it supervises and monitors and given the evolving nature of transactions where the corporate vehicle is being used to defraud the investing public as well as the ever dynamic character of the capital market.

In doing so, informing and educating the public through roadshows, advocacy campaigns, speaking engagements, infomercials, media rounds and social media become crucial. Because they are informed, stakeholders are expected to be empowered to pursue their entrepreneurial and investment plans, comply with good governance standards, and prevent fraud and abuses.

In line with the SEC CAN! (Communication, Advocacy and Network) Strategic Initiative, the Commission *En Banc* has supported the procurement of advertising services to help the SEC ensure the widest and effective dissemination of information to its stakeholders.

# **RATIONALE FOR RADIO ADS**

Radio continues to be one of the most trusted sources of information in the Philippines, especially for a sizable chunk of the population that rely on news heard or picked up from their daily commute.

The Securities and Exchange Commission, in the pursuit of its mission to boost financial literacy and intensify investor education in the country, looks to tap as many avenues for information dissemination as possible to reach the wider public.

In this light, the Commission has retained the placement of radio advertisements as one of the key components of its information campaign for 2024. It has identified three AM radio stations in the country based on audience share, namely **Super Radyo DZBB, DZRH,** and **Bombo Radyo**, as potential suppliers for this project.

Super Radyo DZBB is the flagship AM radio station of GMA Network, the leading broadcast TV network in the country. For the full year 2023, Super Radyo DZBB was the top AM radio station in Mega Manila, garnering an audience share of 29.9%, according to data from Nielsen Radio Audience Measurement (RAM).

DZRH is the flagship AM radio station of the Manila Broadcasting Company, which also operates FM radio stations 90.7 Love Radio, 101.1 Yes!, and 96.3 Easy Rock. In 2023, it followed DZBB as the second leading AM station with an audience share of 28.9%, according to Nielsen RAM.

Meanwhile, Bombo Radyo was chosen for the extent of its reach and performance in the regions. Its broadcast reaches 24 key cities and provinces nationwide, including Laoag, Tuguegarao, Legazpi, Iloilo, Bacolod, Cebu, Roxas, Davao, Butuan, and Cagayan de Oro.

# PROFILE OF TOP RADIO STATIONS

# **Super Radyo DZBB**



Super Radyo DZBB 594 kHz is the flagship AM radio station of RGMA, a subsidiary of GMA Network, Inc. The station is headquartered at the GMA Network Studio Annex, GMA Network Complex in Quezon City, with its transmitter found along Camia St., Brgy. Panghulo in Obando, Bulacan.

The station traces its first broadcast to March 1, 1950, hosted by Robert "Uncle Bob" Stewart from a small office space in Escolta, Manila using mostly second-hand equipment. It has since gone to produce successful programs that mirrored the events of the times, ranging from breaking news to analyses of major national events.

In 2023, DZBB was touted as the top AM radio station in Mega Manila with an audience share of 29.9%, according to data from Nielsen Radio Audience Measurement (RAM).

DZBB's programs focus mostly on news and current affairs, leveraging on resources from GMA Integrated News unit. Prominent programs include *Balitang Balita sa Dobol B, One on One: Walang Personalan* with Connie Sison and Arnold Clavio; *Usap Tayo: Super Kwentuhan* with Mark Salazar and Susan Enriquez; and *Anong Say N'yo?* with Weng dela Pena, among others.

Since 2020, the radio station has started livestreaming its programs through its Facebook page, as well as through GMA News' Youtube channel and website.

### **DZRH**



DZRH is a radio station owned and operated by the Manila Broadcasting Company, and is the second oldest radio station in the Philippines, next only to government-owned DZRB.

The station operates from its studio at the MBC Building, Star City, Vicente Sotto St., CCP Complex, Roxas Boulevard, Pasay City, while its transmitter is located along I. Marcelo St., Brgy. Malanday, Valenzuela. It has nationwide coverage through its relay FM stations across the Philippines, such as Love Radio, 101.1 Yes FM, and 96.3 Easy Rock.

DZRH aims to deliver the latest news not only on national events, but also on those concerning provinces, towns, and barangays. Its radio programs include *Dos por Dos* with Anthony Taberna and Gerry Baja, *Trending n Viral Show* with Karen Ow-Yong, and *Damdaming Bayan* with Deo Macalma, with the latter providing in-debt analysis of the most consequential events in the country.

The station also offers a wide range of topics through its programs such as agriculture and countryside development through the *Balitang Promdi*; calamity relief drives and medical missions through *Operation Tulong*; and entrepreneurial and available government grants for businesses through *Negosyo at Iba Pa*.

# **SCOPE OF WORK**

Radio stations shall work in close coordination with the Commission's information officers and under the supervision of the Commission Secretary, on any of the following:

# A. Live Reads

The host of the show reads the advert in real-time. The average radio advert length will be between 30 to 60 seconds. The SEC shall provide the radio ad script.

# **B.** Advertisement Spots

The service provider shall, on behalf of the SEC, place advertisement on national and regional radio stations. The advertisements may be in the form of 30-second radio ads, radio plugins, content partnerships, advertorials and block-time programs.

### C. Radio Ad Production

The service provider shall, on behalf of the SEC, record and produce 30-second radio advertisements. The SEC shall provide the radio ad script.

# **EXPECTED DELIVERABLES**

The following shall be satisfactorily accomplished and turned over within the timeframe to be agreed upon between the service provider and the SEC:

- 1. **Content Schedule** The service provider shall provide schedule of ads placement, subject to the approval of the Commission; and
- 2. **Progress and Completion Reports** The service provider shall regularly update the Commission about the progress of radio commercials and submit a comprehensive completion report at the end of the radio ads placement. The

report shall include assessment of the effectiveness of the ads and recommendations for adjustments in the strategy, if necessary.

3. **Working files and Materials** - Recording of Radio Commercials in appropriate formats shall be stored in external hard drives or compact discs and/or shall be emailed to the Commission.

# INDICATIVE BUDGET

The approved budget for the contract is Three Million Pesos (P3,000,000.00), inclusive of all applicable taxes, fees, and incidental expenses. Each radio stations will be provided a total budget of **One Million Pesos** (P1,000,000.00) for the placement of ads within one to two months. This covers the service provider's remuneration, actual project costs and other necessary fees.

# **PAYMENT TERMS**

Payment should be made after the submission of accomplishment reports and proof of airing of the SEC radio commercials.

# **OWNERSHIP OF MATERIALS**

Any studies, reports, radio commercials and other materials prepared by the service provider under the contract shall belong to and remain as property of the SEC. The Consultant may retain a copy of such materials for record purposes only.

#### CONFIDENTIALITY CLAUSE

The Service Provider warrants the full confidentiality of all information given by the SEC and/or gathered in relation to the fulfillment of the required services during the course of

the engagement. The Consultant shall not disclose such information and shall return all materials, data and other related documents to the SEC after the completion of the contract.

Furthermore, the Service Provider shall not be engaged by any person or entity whose business or interests are against the interests of the SEC, including corporations with pending cases before the Commission. This prohibition shall subsist for a period of one (1) year after the expiration of the contract.

For this purpose, the Service Provider shall enter into a Non-Disclosure Agreement with the Commission.

### TERMINATION OF THE CONTRACT

Either the SEC may terminate the contract if either party commits a breach of any of the condition of the contract and fails to remedy the same within 30 days from receipt of a written demand from the concerned party for explanation and immediate rectification. In any case, a thirty (30)-day prior written notice must be given to the concerned party.

The failure of either party to perform its obligation under the engagement shall not subject the party to any liability, if such failure is caused or is occasioned by an event of *force majeure*, including but not limited to: an act of God such as fire, explosion, flood, drought and earthquake; war, hostility, invasion, act of foreign enemies, mobilization, requisition or embargo; rebellion, revolution, insurrection, or civil war; riot, commotion, strike or any other labor unrest; and an act or threat of terrorism.
