## INVITATION TO BID

The Securities and Exchange Commission (SEC), through the Securities Regulation Code (SRC) Retention Income intends to apply the sum of Nine Million Eight Hundred Twenty Six Thousand Pesos (Php9,826,000.00) inclusive of VAT and other applicable taxes being the Approved Budget for the Contract (ABC) as payment for the Supply of Services for the Hosting/Co-Location Facility of Servers, Network Equipment and Internet Connection Subscription. Bids received in excess of the ABC shall be automatically rejected during the bid opening.

SEC now invites bids for the Supply of Services for the Hosting/Co-Location Facility of Servers, Network Equipment and Internet Connection Subscription. The Delivery of Goods is required for a period of one (1) year upon receipt of the Notice to Proceed (NTP). Bidders should have completed, within three (3) years prior to the deadline for the submission and opening of bids for this project, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
