Award of contract shall be made to the bidder with lowest quotation for the subject goods which comply with the minimum technical specifications and other terms and conditions stated herein.


Prospective bidders shall accomplish and submit the duly signed Price Quotation Form (Attachment 1) not later than **10:00 A.M. on March 3, 2015** at the Procurement Division, 4<sup>th</sup> floor, SEC Building. Open submission may be submitted, manually or through Facsimile Nos. 584-5330.

Purchaser's Minimum Requirement for the Prospective Bidders:

1. Delivery Schedule: Ten (10) calendar days
2. Bid Validity: Sixty (60) Calendar from submission of bids
3. Delivery Site: General Services Division, 4<sup>th</sup> Floor, SEC Building, Mandaluyong City

The penalty for late deliveries is one tenth (1/10) of one (1) percent of the cost of the unperformed portion of every day of delay. The maximum deduction shall be ten percent (10%) of the contract price. Once the cumulative amount of liquidated damage reaches ten percent (10%) of the contract price, the procuring entity shall rescind the contract without prejudice to other courses of action and remedies open to it.
