**For: VIOLATION OF SEC MEMORANDUM CIRCULAR NO. 18, SERIES OF 2019 ON THE PROHIBITION ON UNFAIR DEBT COLLECTION PRACTICES OF FINANCING COMPANIES (FC) AND LENDING COMPANIES (LC)**

**ORDER**

**WHEREAS**, the Corporate Governance and Finance Department (CGFD) issued Order No. 132, Series of 2020 dated 3 December 2020 (the "*Order*") in the above-titled case revoking Unipeso Lending Company, Inc.'s (Unipeso) Certificate of Authority to Operate as a Lending Company (CA No. 2641);

**WHEREAS**, an attempt to serve a copy of the Order via registered mail to Unipeso's last known registered office address was made on 3 December 2020, in accordance with Part I, Rule IV, Sec. 4-2(b) in relation to Sec. 4-2(a)(iv) of the 2016 Rules of Procedure of the Securities and Exchange Commission (2016 Rules);

**WHEREAS**, the Order was returned unserved on 10 December 2020 due to the addressee being unknown at the given address;<sup>1</sup>

**WHEREAS**, a copy of the Order was likewise served via electronic mail on 7 and 9 December 2020 to Unipeso's official email addresses submitted to the CGFD, in accordance with Part I, Rule IV, Sec. 4-2(b) in relation to Sec. 4-2(a)(v) of the 2016 Rules;

**WHEREAS**, the service via electronic mail was likewise unsuccessful due to the email addresses being unknown;<sup>2</sup>

**WHEREFORE**, in view of the unsuccessful service of the Order despite the diligent efforts of the CGFD to serve copies thereof to Unipeso in accordance with the procedure provided in the 2016 Rules, and there being no appeal, motion for reconsideration, or petition for certiorari filed within the period fixed in the 2016 Rules or the Revised Rules of Court, the Order revoking the Certificate of Authority to Operate as Lending Company of Unipeso (CA No. 2641) is **FINAL AND EXECUTORY**.

Let the Order be entered in the Book of Entries of Judgments of the CGFD, in accordance with Part IV, Rule II, Sec. 2-4(b) of the 2016 Rules, in relation to Rule 36 of the Rules of Court.
