Q: Can we disregard the "Fiber Channel and SATA2 disks concurrently"? Fiber Channel hard disks are no longer supported in the latest models of storage arrays today.

Q: Can we disregard the "Tape Autoloader – existing tape library", the disk storage array system will function accordingly if properly configured and connected to a host (Unix/Win/Linux) not directly to a Tape Autoloader.

Q: Can the Bidder submit an e-signed certificate or authorization from Original Equipment Manufacturer (OEM) as their initial requirement?
