SUBJECT: Recommending Award of Contract for the One (1) Year Subscription to CD Asia Online for 45 accounts

WHEREAS, the Human Resource Administrative Department (HRAD)-Learning and Resource Information Division (LRID), requested the procurement of the **One (1) Year Subscription to CD Asia Online 45 accounts** through Direct Contracting;

WHEREAS, the Bids and Awards Committee (BAC), in its review of Approved Purchase Request (PR) No. 202108130, found that the project with an Approved Budget for the Contract (ABC) of **Seven Hundred Thousand Pesos (Php700,000.00)** is included in the CY 2021 Annual Procurement Plan Item No. II.G.4;

WHEREAS, Section 50, Rule XVI Alternative Methods of Procurement of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184 provides: "**Direct contracting or single source procurement is a method of procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the condition of sale. The offer may be accepted immediately or after some negotiations. Direct Contracting may be resorted to by concerned Procuring Entity under any of the following conditions:**

"a. xxx xxx xxx"

"b. xxx xxx xxx"

"c. Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP"

WHEREAS, based on the certification submitted by **CD Technologies Asia, Inc.**, it has the sole and exclusive authority to use or issue license for the use of, any of the electronic legal publications, the contents or any portion of the electronic legal publications;

WHEREAS, the LRID further certified that based on the survey conducted, CD Asia has no sub-dealer, subcontractor or agent for the electronic publications and there is no other authorized service provider offering this services.

WHEREAS, on August 27, 2021, the BAC sent the Request for Proposal (RFP) to CD Asia through electronic mail;

WHEREAS, on August 31, 2021, CD Asia submitted its offer amounting to **Six Hundred Sixty-Five Thousand Two Hundred Eighty Pesos (Php665,280.00)** together with the following documentary requirements:

1. Certificate of Exclusive Distributorship;
2. Valid Mayor's/Business Permit;
3. Certificate of PhilGEPS Registration
4. Income/Business Tax Return

WHEREAS, the BAC forwarded CD Asia's offer to the End-User Representative for the Technical Evaluation; **WHEREAS**, based on the End-User's Evaluation Report dated September 16, 2021, CD Asia was found to be compliant with the legal, technical and financial requirement of the subject project.

NOW, THEREFORE, on the basis of the foregoing, we, the members of the Bids and Awards Committee (BAC), finding that the conditions for Direct Contracting were satisfied, hereby **RESOLVE** to recommend to the OIC-Director of Human Resource and Administrative Department **Romuald C. Padilla** that the contract for **One (1) Year Subscription to CD Asia Online for 45 accounts** be awarded to **CD Technologies Asia, Inc.** in the amount of **Six Hundred Sixty-Five Thousand Two Hundred Eighty Pesos (Php665,280.00)**, inclusive of VAT.


