**KNOW ALL MEN BY THESE PRESENTS:**

This Agreement made and entered into ~~MAR 31 2022~~ Day of March, 2022 at Pasay City, Metro Manila, Philippines by and between:

**SECURITIES AND EXCHANGE COMMISSION**, a government agency created by virtue of Commonwealth Act No. 83, with office address at 3<sup>rd</sup> Floor, PICC Secretariat Building, PICC Complex, Pasay City, represented herein by its Chairperson **EMILIO B. AQUINO**, hereinafter referred to as the "**SEC**";

**-AND-**

**DBPSC Security Service Incorporated (DBPSCSSI)**, a corporation duly registered and existing under the laws of the Philippines, with principal office address at 2<sup>nd</sup> Floor, Executive Building Ctr., Gil Puyat Avenue, Makati City herein represented by the Vice President, **JOSEPH B. IMBAO**, who is duly authorized to sign this contract as indicated in the Authority of Signatory dated December 14, 2021, a copy of which is hereto attached as Annex "A", hereinafter referred to as "**DBPSCSSI**";

**WITNESSETH:**

**WHEREAS**, the SEC Bids and Awards Committee (BAC) conducted a public bidding for the project, **Service Contract for the Security Manpower Services for Sec Head Office and Extension Offices for A Period of One (1) Year** with an Approved Budget for the Contract of Twenty-One Million One Hundred Fifty Thousand Pesos (Php 21,150,000.00), which was posted on December 10, 2021 at PhilGEPS and SEC websites and in the SEC Bid Bulletin Boards continuously for at least seven (7) days;

**WHEREAS**, the bid of **DBPSCSSI** in the amount of Twenty Million Two Hundred Twenty-Two Thousand Ninety-Five and 22/100 pesos (Php 20,222,095.22) inclusive of VAT was declared as the Single Calculated and Responsive Bid for the project;

**WHEREAS**, pursuant to Section 37 and 39 of the 2016 Revised Implementing Rules and Regulation of Republic Act No. 9184, the Notice of Award was issued to **DBPSCSSI** last February 17, 2022;

**WHEREAS**, on March 9, 2022, **DBPSCSSI** posted its Performance Security in the form of Surety Bond issued by Commonwealth Insurance Company, in the sum of Six Million Sixty-Six Thousand Six Hundred Twenty-Eight and 57/100 (Php 6,066,628.57);

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

1. In this Agreement, the words and expressions shall have the same meaning as are respectively assigned to them in the General and Special Conditions of this Contract.

3. The Contract shall have a term of **one (1) year** commencing on **April 1, 2022 – March 31, 2023**.

4. In consideration of the payments to be made by SEC, DBPSC hereby covenants with SEC to the Service Contract Agreement for the Security Manpower Services for the SEC Main Office and Extension Offices for a Period of One (1) Year in conformity in all respects with the provisions of this Agreement.

Should extra services beyond regular working hours be needed or required by SEC, its authorized representative/s may request DBPSC to perform such services; provided that such extra services shall be within the scope of the existing contract. Payment for extra services actually rendered shall be made in a separate billing, the computation of which shall be on the employee's basic pay.

5. The SEC hereby agrees to pay the DBPSCSSI the amount of **Twenty Million Two Hundred Twenty-Two Thousand Ninety-Five 22/100 pesos (Php 20,222,095.22)** in consideration of its performance of the services and delivery of goods, under the provisions of this Agreement at the times and in the manner prescribed herein.

6. If before the expiration of this Contract, a successor-service provider shall not have been selected and qualified, the SEC, as its interest may require, may extend the same, on a month-to month basis, for a period not exceeding one (1) year, until such time that a successor-service provider shall have been selected and qualified pursuant to the appropriate procurement process;

7. If any legal action is necessary to enforce the terms and conditions of this Agreement, the parties agree that the City of Pasay shall be the sole venue and jurisdiction for the filing of such action.

8. If any term, provision, covenant or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provision hereof shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

9. In carrying out provisions of this Agreement, there shall be no personal liability on the officials and employees of the SEC, it being understood that in such matters they act as agents and representatives of the SEC. Any right of action by DBPSCSSI against any official or employees of the SEC is waived.

10. Any amendment to, or modification of this Agreement will not be effective and binding unless reduced in writing and signed by the authorized representative of the parties.

The foregoing notwithstanding, a party may terminate this Agreement, with the immediate effect upon receipt of the notice of termination, on the ground of:

- (a) Breach by the other party of its obligation herein, or
- (b) Insolvency

Any termination effected under this provision shall be without prejudice to other remedies available to the party who is not in breach under applicable rules.




