Quotation/s that exceeds the Approved Budget for the Contract per lot shall not be considered/accepted. Late quotations shall not be accepted, and only those with complete and valid documents shall be considered.

Award of contract shall be made to the bidder with the Single or Lowest Calculate and Responsive Quotation and that complies with the minimum technical specifications and other terms and conditions stated herein. Any alterations, erasures, or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative.

I. Project Title

Supply and Delivery of One Hundred Twenty-Three (123) units of LED Emergency Light for the Securities and Exchange Commission – Head Office.

II. Requirements

One Hundred Twenty-Three (123) units of LED Emergency Light

III. Objective

To supply and deliver One Hundred Twenty-Three (123) units of LED Emergency Light to be used by the Human Resource and Administrative Department – General Services Division at the SEC Headquarters in Makati and SEC Building in EDSA.

IV. Product Specifications

V. Support Service

Further, the bidder shall have factory trained service representative to furnish all installation, test and start-up supervision necessary for final approval and acceptances well as perform maintenance and repairs on all components as required.
- B. The bidder must have branches/service centers in close proximity with the Head Office.
- C. The bidder must provide eight (8) business/office hours per five (5) days (Monday-Friday) technical support.
- D. Technical Support response and resolution time are as follows:
 - 1. Within one (1) hour upon receipt of notice, either via phone or email.
 - 2. For onsite support, the Bidder must attend to and repair/replace the defective component within three (3) business days.

- 1. Bidders shall provide correct and accurate information required in this form.
- 2. Price quotation/s must be valid for a period of sixty (60) calendar days from the date of submission.
- Price quotation/s. to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
- 4. Quotation/s exceeding the Approved Budget for the Contract shall be rejected.
- 5. Award of contract shall be made to the lowest calculated and responsive quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
- 6. Any interlineations, erasures or overwriting shall be valid only of they are signed or initialed by you or any of your duly authorized representative/s.
- The item/s shall be delivered according to the requirements specified in the Technical Specifications.
- The SEC shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications,
- 9. In case two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest calculated and Responsive Quotation, the GPPB_TSO shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- 10. Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with the existing accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be to the contractor's account.
- 11. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed for day of delay. The SEC shall rescind the contract once the commutative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
