- 1. Bidders shall provide correct and accurate information required in this form.
- 2. Price quotation/s must be valid for a period of sixty (60) calendar days from the date of submission.
- 3. Price quotation/s. to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
- 4. Quotation/s exceeding the Approved Budget for the Contract shall be rejected.
- 5. Award of contract shall be made to the lowest calculated and responsive quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
- 6. Any interlineations, erasures or overwriting shall be valid only of they are signed or initialed by you or any of your duly authorized representative/s.
- 7. The item/s shall be delivered according to the requirements specified in the Technical Specifications.
- 8. The SEC shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications,
- 9. In case two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest calculated and Responsive Quotation, the GPPB_TSO shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- 10. Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with the existing accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be to the contractor's account.
- 11. Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed for day of delay. The SEC shall rescind the contract once the commutative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

To supply and deliver Five (95) units of Portable Air-conditioning Unit to be used by the following offices/department:

- A. 1 unit Office of the General Accountant Conference Room
- B. 1 unit Human Resource and Administrative Department General Services Division
- C. 1 unit Executive Lounge
- D. 2 units Commission Room

IV. Product Specifications

A. Bidder should be capable of providing Five (5) units of portable air-conditioning unit, with the following features and capabilities or higher.

Further, the bidder shall have factory trained service representative to furnish all installation, test and start-up supervision necessary for final approval and acceptances as well as perform maintenance and repairs on all components as required.
- B. The bidder must have branches/service centers in close proximity with the Head Office.
- C. The bidder must provide eight (8) business/office hours per five (5) days (Monday-Friday) technical support.
- D. Technical Support response and resolution time are as follows:
 - 1. Within one (1) hour upon receipt of notice, either via phone or email.
 - 2. For onsite support, the Bidder must attend to and repair/replace the defective component within three (3) business days.
