Recommending the Award of Contract

Whereas, on July 15, 2022, the Office of General Accountant (OGA) submitted to the Procurement Division the approved Purchase Request (PR) No. 202207167 for the project, **Printing of the First Edition the SEC Oversight Assurance Review (SOAR) Public Inspection Report**;

Whereas, the Bids and Award Committee (BAC), in its review of the said PR, found that the project with an Approved Budget for the Contract (ABC) of **Sixty-Five Thousand Pesos (₱ 65,000.00)** is reflected in item no. II.78 of the 2022 Supplemental Annual Procurement Plan No. 2022-10;

Whereas, based on the Post-Qualification and Evaluation Report dated August 5, 2022, **AJ & TJ Printing** was established to be the most responsive and compliant with the legal, technical, and financial requirements;

Now, Therefore, on the basis of the foregoing, the Bids and Awards Committee **RESOLVES** the following:

1. To declare the bid of AJ & TJ Printing in the amount of **Sixty-Four Thousand Five Hundred Pesos (Php 64,500.00)** inclusive of VAT, as the Lowest Calculated and Responsive Quotation; and
2. To recommend to the OGA Director Emmanuel Y. Artiza, that the contract for the **Printing of the First Edition the SEC Oversight Assurance Review (SOAR) Public Inspection Report** be awarded to **AJ & TJ Printing** in the amount of **Sixty-Four Thousand Five Hundred Pesos (Php 64,500.00)** inclusive of VAT.


