DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 2022-05-141 (Annex A) was received on 20 May 2022 for the **SUPPLY, DELIVERY AND INSTALLATION OF 5 UNITS OF 5-TONNER INVERTER FLOOR MOUNTED AIR CONDITIONING UNITS FOR SEC DAVAO EXTENSION OFFICE** with approved budget for the contract in the amount of **ABC Nine Hundred Eighty Thousand Pesos (Php 980,000.00)**;

WHEREAS, Request for Quotation No. 2022-SVP-50(Reposting) was posted in PhilGEPS on 29 July 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


