DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-109)

WHEREAS, Purchase Request No. 202208225 (Annex A) was received on 25 August 2022 for the **Dismantling of Old Carpet, Supply, Delivery and Installation of New Carpet Tiles for The Securities and Exchange Commission** with approved budget for the contract in the amount of **Three Hundred Twenty Thousand Pesos (Php 320,000.00)**;

WHEREAS, Request for Quotation No. 2022-SVP-67 was posted in PhilGEPS on 26 August 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
