### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-113)

**WHEREAS**, Purchase Request No. 202207187 (Annex A) was received on 03 August 2022 for the **SUPPLY AND DELIVERY OF FIVE (5) UNITS OF PORTABLE AIR-CONDITIONING UNIT AT SEC HEAD OFFICE** with approved budget for the contract in the amount of **ABC One Hundred Thirty Thousand Pesos (Php 130,000.00)**;

**WHEREAS**, Request for Quotation No. 2022-SVP-58 was posted in PhilGEPS on 18 August 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 18 August 2022, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;
