WHEREAS, Purchase Request No. 2022-07-165 (Annex A) was received on 22 July 2022 for the **SUBSCRIPTION TO VIDEO CONFERENCING SOFTWARE AS A SERVICE SOLUTION FOR THE PERIOD OF ONE (1) YEAR** with approved budget for the contract in the amount of **ABC Nine Hundred Sixty-Eight Thousand Pesos (Php 968,000.00)**;
