**BAC RESOLUTION No. 2022-061**

**Recommending Award of Contract for the Supply and Delivery of DSLR Camera Set and Accessories for DSLR Camera**

**Whereas**, on February 8, 2022, the Human Resource and Administrative Department (HRAD), submitted to the Procurement Division its approved Purchase Request (PR) No. 2022-01005/06 with QR Code for the **Supply and Delivery of DSLR Camera Set and Accessories for DSLR Camera**;

**Whereas**, the Bids and Awards Committee (BAC), in its review of the said PR, found that the project with an Approved Budget for the Contract (ABC) of Two Hundred Seventeen Thousand Pesos (Php217,000.00) is reflected in item No.II.G.20/21 of the 2022 Annual Procurement Plan;

**Whereas**, the BAC through its Secretariat, posted the Request for Quotation (RFQ) No. 2022-SVP-07 for the above-mentioned project in the SEC and PhilGEPS websites as well as in the SEC Bulletin Boards continuously for at least seven (7) days starting on April 11, 2022

**Whereas**, the said RFQ were sent to the following prospective bidders, namely: (1) ALPHA DIGIZONE MARKETING, (2) AVID SALES CORPORATION (Glorietta Branch) and (3) AVID SALES CORPORATION (Solenad Branch);

**Whereas**, on April 19, 2022, deadline of submission and opening of bids, only ULY TECH TRADING submitted its quotation, together with the eligibility and technical documents;

**Whereas**, the BAC, in its preliminary examination of bids, found **ULY TECH TRADING** compliant with the minimum requirements and its financial bid in the amount of **Two Hundred Thirteen Thousand Seven Hundred Fifty Pesos (Php 213,750.00)** was within the ABC and has declared **ULY TECH TRADING** as the Lowest Calculated Bid;

**Whereas**, on May 6, 2022, the BAC forwarded the eligibility, technical and financial documents of ULY TECH TRADING to the Technical Working Group (TWG) for Post-Qualification and Evaluation;

**Whereas**, based on the TWG Post-Qualification and Evaluation Report submitted to the BAC on May 17, 2022, **ULY TECH TRADING** was found to be compliant with the minimum eligibility, technical and financial requirements;

**Now, Therefore**, on the basis of the foregoing, the Bids and Awards Committee hereby **RESOLVES** the following:

1. To declare the bid of **ULY TECH TRADING** in the amount of Two Hundred Thirteen Thousand Seven Hundred Fifty Pesos (Php213, 750.00) inclusive of VAT as the Lowest Calculated and Responsive Bid; and
2. To recommend to the SEC Director III, HRAD, Filbert Catalino F. Flores III, that the contract for the **Supply and Delivery of DSLR Camera Set and Accessories for DSLR Camera** be awarded to **ULY TECH TRADING** in the amount of **Two Hundred Thirteen Thousand Seven Hundred Fifty Pesos (Php 213, 750.00)** inclusive of VAT.
