DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-130)

WHEREAS, Purchase Request No. 202208212 was received on August 18, 2022 for the **SUPPLY, DELIVERY AND INSTALLATION OF THE DENTAL CHAIR AT THE SEC HEADQUARTERS** with approved budget for the contract in the amount of **FOUR HUNDRED TWENTY THOUSAND PESOS (Php 420,000.00)**;

WHEREAS, Request for Quotation No. 2022-SVP-64 was posted but was declared failure due to non-compliance on the product demonstration as part of the requirement;

WHEREAS, Request for Quotation No. 2022-SVP-79, a reposting of RFQ No. 2022-SVP-64,, was posted in PhilGEPS on 20 September 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No.9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 20 September 2022, invited Ordent Trading, DSC Inc., and Bio-Dent Medical Equipment Trading (Annex C is proof), the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s on September 23, 2022, the following quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of all accepted proposals (Annex E is Evaluation Report), it was determined that the quotation of New Citizen's Dental Supply is the lowest calculated but it was disqualified due to non-compliance in the product demonstration or Proof of Concept on the product;

WHEREAS, the quotation of DSC, Inc., was subjected to evaluation and on October 5, 2022, a product demonstration was conducted by the Technical Working Group and End-user, where no adverse finding was noted;


WHEREAS, the quotation of DSC, Inc., was determined to be responsive to all requirements and was established to be compliant with the legal, technical and financial requirements; and

NOW THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **DSC, Inc.** in the amount of **THREE HUNDRED NINETY SEVEN THOUSAND PESOS (₱397,000.00)** as lowest calculated and responsive quotation for the **SUPPLY, DELIVERY AND INSTALLATION OF THE DENTAL CHAIR AT THE SEC HEADQUARTERS**, and to recommend to the Head of the Procuring Entity the award of contract to the contractor / bidder in accordance with the terms and conditions of the Request for Quotation No. 2022-SVP-79 and accepted quotation.


