### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-126)

**WHEREAS**, Purchase Request No. 202208223 (Annex A) was received on 26 August 2022 for the **SUPPLY AND DELIVERY OF MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES** with approved budget for the contract in the amount of **ABC Six Hundred Thirty-Three Thousand (Php 633,000.00)**;

**WHEREAS**, Request for Quotation No.2022-SVP-69 consisting of two (2) lots was posted in PhilGEPS on 31 August 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 31 August 2022, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

**WHEREAS**, on or before the deadline to submit quotation/s- i.e., September 09,2022, 05PM) – only one (1) quotation was received and opened for *Lot 1* Medicines and Medical Supplies, however *Lot 2* of the RFQ was declared a failure (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of accepted proposal (Annex E is Evaluation Report), it was determined that the quotation of Ayamed Drug Distributor in the amount of **TWO HUNDRED FORTY-THREE THOUSAND ONE HUNDRED TWENTY PESOS (₱243,120.00)** is the single/lowest calculated and responsive quotation for the subject procurement.
