DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-110)

WHEREAS, Purchase Request No. 202208213 was received on August 18, 2022 for the **SUPPLY AND DELIVERY OF THE EXTRAORAL SUCTION MACHINE** with approved budget for the contract in the amount of **FIFTY FIVE THOUSAND PESOS (Php 55,000.00)**;

WHEREAS, Request for Quotation No. 2022-SVP-65 was posted in PhilGEPS on 19 August 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No.9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 19 August 2022, invited Ordent Trading, DSC Inc., Bio-Dent Medical Equipment Trading, and Denpres Dental Depot Corporation (Annex C is proof), the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s on August 23, 2022, the following quotations were received and opened (Annex D is Abstract of Quotation):


