**DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION
AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2022-112)

WHEREAS, Purchase Request No. 202202080 (Annex A) was received on 1 March 2022 for the Supply and Delivery of 11 Unit POS Printer of (2 units for SEC Main and 9 Units for SEC-Extension Offices) with approved budget for the contract in the amount of **Three Hundred Sixty Eight Thousand Five Hundred Pesos (P368,000.00)**;

WHEREAS, Request for Quotation No. RFQ No. 2022-SVP-22 was posted in PhilGEPS on 14 July 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 14 July 2022), invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s- i.e., July 21, 2022, 5:00 PM – the following quotations were received and opened (Annex D is Abstract of Quotation):
