DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-127)

WHEREAS, Purchase Request No. 202207184 (Annex A) was received on 6 September 2022 for the SSL Certificate (Wildcard)-1 with approved budget for the contract in the amount of **Seventy-Three Thousand Four Hundred Forty-One Pesos and 47/100 (P73,441.47)**;

WHEREAS, Request for Quotation No. RFQ No. 2022-SVP-73 was posted in PhilGEPS on 15 September 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 14 September 2022, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;


