DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-153)

WHEREAS, Purchase Request No. 2022-10-268 (Annex A) was received on 18 October 2022 for the **SUPPLY, DELIVERY, AND INSTALLATION OF TWO (2) UNITS 1.5HP SPLIT TYPE** with approved budget for the contract in the amount of **Two Hundred Thousand Pesos (Php 200,000.00)**;

WHEREAS, Request for Quotation No. 2022-SVP-88 was posted in PhilGEPS on 20 October 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
