### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-154)

**WHEREAS**, Purchase Request No. 202209230 (Annex A) was received on 20 September 2022 for the Production of Videos and Radio Commercials with approved budget for the contract in the amount of **Ten Million Pesos (Php10,000,000.00)**;

**WHEREAS**, Invitation to Bid and bidding documents for Production of Videos and Radio Commercials under Public Bidding No. 2022-36 was posted in PhilGEPS on 24 September 2022 for the abovementioned procurement (Annex B is proof). The same Invitation to Bid was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on October 17, 2022 10:00 A.M.;

1. to declare the bid of Marcus Phoenix Media Production Corp., in the amount of **FIVE MILLION THREE HUNDRED FORTY-FIVE THOUSAND SIX HUNDRED SEVENTY-EIGHT PESOS and 90/100 (₱5,345,678.90)**, inclusive of VAT and applicable taxes, as the Lowest Calculated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the Production of Videos and Radio Commercials under Public Bidding No. 2022-36, be awarded to Marcus Phoenix Media Production Corp.


