BAC Resolution No. 2022-087

WHEREAS, the Securities and Exchange Commission (SEC), through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the Procurement of **FLEET CARD OF GASOLINE AND DIESEL REQUIREMENTS OF SEC OFFICIAL AND SERVICE VEHICLES FOR SEC HEAD OFFICE AND EXTENSIONS OFFICES (Re-bidding)** in PhilGEPS, SEC website, and in SEC Bulletin Boards continuously for at least seven (7) days starting June 15, 2022;

WHEREAS, the project with an Approved Budget for Contract (ABC) of Seven Million Two Hundred Thousand Pesos (Php 7,200,000.00) as indicated in the approved Purchase Request No. 202205138 is included in the Supplemental Annual Procurement Plan No. 2022-05 under item no. A.3;

WHEREAS, on June 22, 2022, only Petron Corporation, (Petron) attended the scheduled Pre-bid conference;

WHEREAS, during the deadline for the Submission and Opening of Bids on July 6, 2022, only Petron submitted bid;

WHEREAS, on the same date, after the preliminary examination of bids, the BAC using the non-discretionary "pass/fail" criterion, determined the submission of Petron as "passed" for complying with all the eligibility and technical requirement as stated in the Bidding Document;

WHEREAS, the BAC proceeded to the opening of the financial envelope of Petron and that its financial bid in the amount of Seven Million One Hundred Ninety-Nine Thousand Eight Hundred Two Pesos (Php 7,199,802.00) inclusive of VAT is within the ABC;

WHEREAS, on July 8, 2022, the BAC notified PETRON to submit its post-qualification documents within a non-extendible period of (5) calendar days;

WHEREAS, on July 13, 2022, ICI submitted its post-qualification documents to the BAC and was endorsed to the Technical Working Group (TWG) for post-qualification and evaluation process;


WHEREAS, the TWG, in accordance with its mandate under Section 34, Rule X of RA9184 and its IRR, conducted a post-qualification and evaluation process;

WHEREAS, based on TWG Post-Qualification and Evaluation submitted to the BAC on August 10, 2022, ICI was established to be compliant with the legal, technical and financial requirements of the project;

NOW, THEREFORE, on the basis of the foregoing, the Bids and Awards Committee, hereby **RESOLVES** the following:

1. To declare the bid of PETRON for the above-mentioned project, in the amount of Seven Million One Hundred Ninety-Nine Thousand Eight Hundred Two Pesos (Php 7,199,802.00) inclusive of VAT as the **Single Calculated and Responsive Bid**;
2. To recommend to the Director of HRAD, Filbert Catalino F. Flores III, that the contract for the **FLEET CARD OF GASOLINE AND DIESEL REQUIREMENTS OF SEC OFFICIAL AND SERVICE VEHICLES FOR SEC HEAD OFFICE AND EXTENSIONS OFFICES (Re-bidding)** be awarded to PETRON CORPORATION, in the amount of **Seven Million One Hundred Ninety-Nine Thousand Eight Hundred Two Pesos (Php 7,199,802.00) inclusive of VAT**.


