

CONTRACT AGREEMENT NO. 2022-03-52

THIS AGREEMENT made the 19th day of October 2022 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, represented herein by, **FILBERT CATALINO F. FLORES III**, HRAD DIRECTOR, of the one part and the **DEVELOPMENT ACADEMY OF THE PHILIPPINES**, represented herein by **LEA S. PERALTA**, PROJECT MANAGER, with office address at DAP Building, San Miguel Avenue Ortigas Center, Pasig Center, Philippines (hereinafter called "the Servicing Agency") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Learning Service provider for the Conduct of Programs for the FY 2022-Regulatory Impact Assessment for Junior Staff-1 Batch ("the Project") and has accepted a Proposal by the Servicing Agency for the supply of those goods and services in the sum of *Two Hundred Forty Thousand Pesos (Php 240,000.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference
 - (b) Request for Proposal
 - (c) Servicing Agency's proposal, including the Eligibility requirements, documents and/or statements submitted
 - (d) Notice of Award of Contract and the Servicing Agency's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal
