

CONTRACT AGREEMENT 2022-3-58

THIS AGREEMENT made the 20 day of October 2022 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, represented herein by FILBERT CATALINO F. FLORES III, of the one part and **BUSINESS MAKER ACADEMY, INC.**, herein represented by MYLENE B. MANALO, Authorized Representative, with office address at Suite 1503A West Tower PSEC Bldg., Exchange Road Ortigas Center, Pasig City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Learning Service Provider for the Conduct of Programs for the FY 2022- Training for Extension Offices(EO's) Service Design 1 Batch Lot 4 ("the Project") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Php 240,000.00 (Two Hundred Forty Thousand Pesos)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference
 - (b) Request for Proposal
 - (c) Winning bidders proposal, including the Eligibility requirements, documents and/or statements submitted
 - (d) Notice of Award of Contract and the winning bidders conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Proposal.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal.

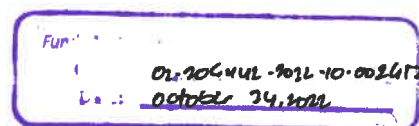
