WHEREAS, Purchase Request No. 202209251 (Annex A) was received on 18 October 2022 for the **RADIO ADVERTISEMENTS** with approved budget for the contract in the amount of **THREE MILLION PESOS (Php 3,000,000.00)**;

WHEREAS, the abovementioned suppliers submitted the following quotations:




