WHEREAS, Purchase Request No. 2022-10-264 (Annex A) was received on 13 October 2022 for the **SUPPLY OF LABOR AND MATERIALS FOR REPAINTING AND ROOFING WORKS** with approved budget for the contract in the amount of **Eight Hundred Ninety Thousand Nine Hundred Eight and 25/100 (Php 890,908.25)**;

WHEREAS, Request for Quotation No. 2022-SVP-81 was posted in PhilGEPS on 14 October 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange 4
