**DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION
AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2022-152)

WHEREAS, Purchase Request No. 2022-10-267 (Annex A) was received on 13 October 2022 for the **SUPPLY, DELIVERY, AND INSTALLATION OF OFFICE CUBICLES** with approved budget for the contract in the amount of **One Hundred Fifty Thousand Pesos (Php 150,000.00)**;


