SEC ADVISORY

This is to inform the public that TETHER-PAY/TETHER.PAY.COM /TETHER PAY LTD./TETHER PAY LIMITED IS NOT AUTHORIZED TO SOLICIT INVESTMENTS FROM THE PUBLIC.

This Advisory is prompted by the information received and gathered by the Securities and Exchange Commission (“Commission”) that individuals or group of persons headed by its CEO, **RENDON DURAN** is soliciting investments from the public purportedly to be invested in foreign exchange and cryptocurrency trading.

TETHER-PAY/TETHER.PAY.COM/TETHER PAY LTD./TETHER PAY LIMITED entices the public to invest online or through the internet an amount ranging from 10 USDT up to 300,000 USDT (equivalent to P557.50 up to P1,672,500) where investors can earn guaranteed 3% to 10% daily profit in 70 days or equivalent to 210% for the same period (Php 1,169 up to Php 3,515,250).

In view thereof, the public is advised NOT TO INVEST or STOP INVESTING in any investment scheme being offered by **TETHER-PAY/TETHER.PAY.COM /TETHER PAY LTD./TETHER PAY LIMITED** vis-à-vis **RENDON DURAN** as well as to any other entities having the same or similar schemes and to exercise caution in dealing with any individuals or group of persons soliciting investments or recruiting investors for and on behalf of **TETHER-PAY/TETHER.PAY.COM /TETHER PAY LTD./TETHER PAY LIMITED** vis-à-vis **RENDON DURAN**.
