WHEREAS, Purchase Request No. 2022-10-267 (Annex A) was received on 13 October 2022 for the **TRANSFER OF ACTIVE DIRECTORY SERVER WITH ACCESSORIES** with approved budget for the contract in the amount of **Thirty-Five Thousand Pesos (Php 35,000.00)**;


