DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 2022-09-239 (Annex A) was received on 16 September 2022 for the **Streaming Services** with approved budget for the contract in the amount of **Three Hundred Sixty-Thousand Pesos (Php 360,000.00)**;


