DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-127)

WHEREAS, Purchase Request No. 202209242 (Annex A) was received on 23 September 2022 for the Supply, Delivery of Genuine Brother Consumables for Brother HL-L3270CDW Printer of the Commission (2 units) with approved budget for the contract in the amount of **One Hundred Eleven Thousand Nine Hundred Sixty-Nine Thousand Pesos (P111,969.00)**;

WHEREAS, Request for Quotation No. RFQ No. 2022-SVP-83 was posted in PhilGEPS on 24 October 2022 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


