DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 202301021 (Annex A) was received on 26 January 2023 for the RENTAL OF 1-UNIT MICROFILM READER/PRINTER MACHINE WITH FULL TIME OPERATOR with approved budget for the contract in the amount of EIGHT HUNDRED THOUSAND PESOS (₱800,000.00);
