### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

**WHEREAS**, Purchase Request No. 202301025 (Annex A) was received on 25 January 2023 for the **SUPPLY AND DELIVERY OF CUSTOMIZED HOLOGRAM STICKER (TAMPER EVIDENT) FOR THE SECURITIES AND EXCHANGE COMMISSION** with approved budget for the contract in the amount of **SEVENTY-SEVEN THOUSAND PESOS (P77,000.00)**;


