### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

**WHEREAS**, Purchase Request No. 20230113 (Annex A) was received on 24 January 2023 for the **SUPPLY AND DELIVERY OF SCAFFOLDING MATERIALS** with approved budget for the contract in the amount of **Forty-Five Thousand Two Hundred Pesos (Php 45,200.00)**;

**WHEREAS**, Request for Quotation AMP No. 2023-001, was posted in PhilGEPS on January 26, 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
