### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2022-150)

**WHEREAS**, Purchase Request No. 202209240 was received on 19 September 2022 for the **SUBSCRIPTION AND UPGRADE OF GOOGLE E-MAIL SERVICES ("Project")** with approved budget for the contract in the amount of **FIVE MILLION THREE HUNDRED SEVENTY THOUSAND THREE HUNDRED PESOS (Php 5,370,300.00)];**

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2022-35 was posted in PhilGEPS on 22 September 2022 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 14 October 2022;

**NOW THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. to declare the bid of e-PLDT Inc. in the amount of **FIVE MILLION SIX THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (Php5,006,888.00)**, inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUBSCRIPTION AND UPGRADE OF GOOGLE E-MAIL SERVICES** under Public Bidding No. 2022-35, be awarded to e-PLDT Inc.


