

AGREEMENT


THIS AGREEMENT made the MAR 8 1 2023 2023 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, Makati Avenue, Salcedo Village, Bel-air, Makati City, represented by Oliver V. Chato, of the one part, and **MESSAGING SOLUTIONS PROVIDER, INC.**, with office address at MSPI Place, 1294 Batangas Street, Makati City 1200, Philippines, represented by Daniel M. Gomez, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Preventive Maintenance for Digital Mailing Machines** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Forty-Nine Thousand Three Hundred Seventeen Pesos And 70/100 (P49,317.70)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (d) Notice of Award of Contract and the winning bidders *conforme* thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Quotation.
