WHEREAS, Purchase Request No. 202301022 (Annex A) was received on 23 January 2023 for the **PREVENTIVE MAINTENANCE FOR DIGITAL MAILING MACHINES** with approved budget for the contract in the amount of **One Hundred Thousand Pesos (Php 100,000.00)**;

WHEREAS, the Annual Procurement Plan for 2023 of the Securities and Exchange Commission states Direct Contracting as the mode of procurement for the abovementioned project;

WHEREAS, under Section 50 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, Direct Contracting may be resorted to by concerned Procuring Entities under any of the following conditions:



WHEREAS, **Messaging Solutions Provider, Inc.**, submitted its proposal which the BAC found to be acceptable and responsive;


