DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-029)

WHEREAS, Purchase Request No. 2023-02-049 (Annex A) was received on 23 February 2022 for **PRINTING, SUPPLY, AND DELIVERY OF POSTERS** with approved budget for the contract in the amount of **TWO HUNDRED THOUSAND PESOS (Php 200,000.00)**;

WHEREAS, Request for Quotation AMP No. 2023-015 was posted in PhilGEPS on 01 March 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 01 March 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;
