DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-017)

WHEREAS, Purchase Request No. 202301036 (Annex A) was received on 08 February 2023 for the **SUPPLY AND DELIVERY OF GENUINE CONSUMABLES FOR GESTETNER COPYPRINTER MODEL DD3344 OF THE HRAD** with an approved budget for the contract of **EIGHTY SEVEN THOUSAND EIGHT HUNDRED FORTY-THREE PESOS AND 28/100** (Php 87,843.28):

WHEREAS, Request for Quotation AMP No. 2023-014 was posted in PhilGEPS on February 11, 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, on or before the deadline to submit quotation/s- i.e., February 17, 2023, only the bidder below submitted its quotation:


