### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

**WHEREAS**, Purchase Request No. 202301037 was received on 08 February 2023 for the **SUPPLY AND DELIVERY OF SPECIALTY PAPER** with approved budget for the contract in the amount of **ONE MILLION FOUR HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED PESOS (Php 1,478,400.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for **SUPPLY AND DELIVERY OF SPECIALTY PAPER** under Public Bidding No. 2023-010 was posted in PhilGEPS on 13 February 2023 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 6 March 2023, 9:00 A.M.;

**WHEREAS**, on or before the deadline, the following contractors/bidders submitted bids with corresponding remarks/rating;

**WHEREAS**, on 16 March 2023 and after post-qualification, the bid of Philippine Vision Group Inc. was post-disqualified due to the non-compliance of the goods being offered with the minimum technical specifications;




**NOW THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

**RESOLVED**, this 21st day of March 2023 at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, Philippines.






