



DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-019)

WHEREAS, Purchase Request Nos. 202301010, 202301014, 202301015, 202301016, and 202301017 (Annex A) were received on 23 January 2023 for the **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS AND ELECTRICAL SUPPLIES** with approved budget for the contract in the amount of **Three Million Four Hundred Fifty-Five Thousand Five Hundred Fifty-Eight Pesos (Php 3,455,558.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS AND ELECTRICAL SUPPLIES** under Public Bidding No. 2023-001 was posted in PhilGEPS on 28 January 2023 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 20 February 2022;


WHEREAS, on or before the deadline, the following contractors/bidders submitted bid with corresponding remarks/rating;

WHEREAS, after the necessary bid evaluation on 21 February 2023, the bids of Clearshot Builders, OPC., were determined and declared as the Single/Lowest Calculated Bids, and notice was sent to the latter requiring the submission post-qualification documents;

WHEREAS, on 27 February 2023 and after post-qualification, the bids of Clearshot Builders, OPC., were determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

- To declare the bid of Clearshot Builders, OPC., for Lot No. 2 in the amount of **Seven Hundred Sixty-Two Thousand Six Hundred Eight and 36/100 (₱762,608.36)**, for Lot No. 3 in the amount of **Five Hundred Ninety-One Thousand One Hundred Seventy-Nine and 36/100 (₱ 591,179.36)**, for Lot No.4 in the amount of **Five Hundred Six Thousand Two Hundred Ninety-Seven and 20/100 (₱ 506,297.20)**, and for Lot No.5 in the amount of **Three Hundred Fifty-Six Thousand Three Hundred Ten and 48/100 (₱356,310.48)**, all inclusive of VAT and applicable taxes, as the Single/Lowest Calculated and Responsive Bids for the above-mentioned projects; and
