DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-067)

WHEREAS, Purchase Request No. 202304114 (Annex A) was received on 13 April 2023 for the **SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION MATERIALS FOR RENOVATION OF THE GROUND FLOOR LOBBY** with approved budget for the contract in the amount of **Six Hundred Thousand Pesos (Php 600,000.00)**;

WHEREAS, Request for Quotation AMP No. 2023-036 was posted in PhilGEPS on 14 April 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 14 April 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e., 19 April 2023 12:00PM – the following quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of all accepted proposals (Annex E is Evaluation Report), it was determined that the quotations of E. Antazo Construction Supplies and APO Philtrade and Trading Services, Inc. in the amount of **Five Hundred Sixty Thousand Pesos (₱560,000.00)** are the lowest calculated and responsive quotations;


WHEREAS, pursuant to GPPB Circular 06-2005, to resolve cases where an occurrence of a tie among bidders takes place, procuring entity may use "draw lots" or similar methods of chance;

WHEREAS, on 25 April 2023, toss-coin method was conducted and the result favored E. Antazo Construction Supplies;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of E.Antazo Construction Supplies in the amount of **Five Hundred Sixty Thousand Pesos (₱560,000.00)** as lowest calculated and responsive quotation for the **SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION MATERIALS FOR RENOVATION OF THE GROUND FLOOR LOBBY**, and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-036 and accepted quotation.
