WHEREAS, Purchase Request No. 202302044 (Annex A) was received on 2 March 2023 for the **MICROSOFT AZURE DEVOPS SERVICE SUBSCRIPTION** with approved budget for the contract in the amount of **Two Hundred Sixty-Seven Thousand Three Hundred Thirty-Three Pesos and 41/100 (P267,336.41)**;


WHEREAS, on or before the deadline to submit quotation/s, 17 March 2023, only one quotation was received and opened (Annex D is Abstract of Quotation):




