### DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-042)

**WHEREAS**, Purchase Request No. 2023-02-045 (Annex A) was received on 23 February 2023 for **SUPPLY AND DELIVERY OF DASHCAM** with approved budget for the contract in the amount of **THREE HUNDRED THOUSAND PESOS (Php 300,000.00)**;

**WHEREAS**, Request for Quotation AMP no. 2023-020 was posted in PhilGEPS on 03 March 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 03 March 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

**WHEREAS**, on or before the deadline to submit quotation/s- March 8, 2023, 12NN – the following quotations were received and opened (Annex D is Abstract of Quotation):




**WHEREAS**, the supplier, **Adato Dashcam & Gadget Store**, who offered the lowest quotation at **TWO HUNDRED ONE THOUSAND FIVE HUNDRED PESOS (₱201,500.00)** failed to meet the required specification.

**WHEREAS**, after verification and validation of all accepted proposals (Annex E is Evaluation Report), it was determined that the quotation of **Ablaze Marketing** in the amount of **TWO HUNDRED SIXTY FOUR THOUSAND ONE HUNDRED TWENTY PESOS (₱264,120.00)** is the single/lowest calculated and responsive quotation for the subject procurement.

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **Ablaze Marketing** in the amount **TWO HUNDRED SIXTY FOUR THOUSAND ONE HUNDRED TWENTY PESOS (₱264,120.00)** as single/lowest calculated and responsive quotation for the **SUPPLY AND DELIVERY OF DASHCAM**, and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP no. 2023-020 and accepted quotation.


